

### What is CONSENT?

Verbal & non-verbal permission for sexual activity.

Consent must be freely-given, ongoing & enthusiastic.







### Campbus SEXUAL ASSAULT



A study of 1,882 male college students found 120, or 6%, were rapists.

Less than 1% of accused sexual perpetrators are disciplined by the school.

The average campus

based sexual predator will have 6 victims.

In a college study by Dr. David Lisak, 76 serial rapists committed 1,045 offenses.



"NO PERSON IN THE UNITED STATES SHALL, ON THE BASIS OF SEX, BE EXCLUDED FROM PARTICIPATION IN, BE DENIED THE BENEFITS OF, OR BE SUBJECTED TO DISCRIMINATION UNDER ANY EDUCATION PROGRAM OR ACTIVITY RECEIVING FEDERAL FINANCIAL ASSISTANCE."



#### WHO IS INCLUDED UNDER TITLE IX?

Any education institution that receives federal funding

#### **Challenges?**

Some private and faith based schools that do not receive federal funding are not required to abide by Title IX

#### IS TITLE IX ONLY FOR WOMEN?

Title IX protects any student that is harassed or discriminated due to their gender or gender identity

#### Challenges?

LGBTQIA+ students are not always provided adequate protections due to lack of understanding of Title IX

#### WHO DOES IT PROTECT?

Title IX protects both staff and students.

Title IX includes harassment by: staff to students, staff to staff, & student to student

Harassment on campus and at school related events is considered a Title IX violation.

Harassment based on
sexual orientation
Stalking

For K-12 schools, bullying can fall under Title IX if the bullying is of a sexual nature






