Position: Rural Collaboration Coordinator

Responsible To: Rural and Disabilities Projects Manager

Primary Responsibility: To improve responses to survivors of sexual assault, domestic violence, and stalking in rural Kansas communities by working with rural KCSDV member programs and allied professionals to strengthen and formalize their collaborations. Coordinate and work closely with rural member programs and other KCSDV staff and projects to develop programming, best practice strategies, protocols, and training curricula for responding to the needs of rural survivors of sexual assault, domestic violence, and stalking.

Specific Duties:

- Gather and become familiar with information and resources from KCSDV member programs, other state
 coalitions, and national technical assistance providers on collaboration development to address sexual assault,
 domestic violence, and stalking in rural communities.
- Become familiar with the policies, procedures, and practices of other agencies, government or otherwise, that impact survivors of sexual assault, domestic violence, and stalking.
- Become familiar with Kansas law that impacts survivors of sexual assault, domestic violence, and stalking.
- Organize and facilitate discussions with rural member programs to identify gaps and needs related to formal
 collaboration with allied professionals to improve the response to sexual assault, domestic violence, and stalking
 in their communities.
- Work with rural advocacy programs to establish collaborations, focusing on both criminal justice and human services, including law enforcement, SARTs/ CCRs, homeless services providers, and child welfare providers.
- Support KCSDVs Housing Advocacy Coordinator to build relationships with homeless service providers that address the housing needs of survivors in rural communities.
- Provide training and technical assistance in rural communities on best practices for rural collaboration development, including best practices for formal and informal CCRs and SARTs.
- Develop and conduct trainings that address the identified gaps and needs in responding appropriately to sexual assault, domestic violence, and stalking.
- Develop and provide training to rural SARTs and SANEs.
- Work with rural member programs to develop and strengthen formal collaboration and responses to survivors in their communities.
- Provide ongoing technical assistance on issues related to best practices when working with rural survivors of sexual assault, domestic violence, and stalking.
- Assist with other KCSDV duties as assigned.
